ORDINANCE NO. 16-573 ORDINANCE LEVYING AND ASSESSING TAXES OF THE NORTHLAKE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017

BE IT ORDAINED by the Board of Library Trustees of the Northlake Public Library District as follows:
